About CRU

Community Resource Unit (CRU) is an incorporated association. Its origins lie in a 1987 initiative of Queensland families, professionals and people with disabilities who recognised that legislative change was insufficient to support authentic change for people with disabilities and their families. CRU was developed to support grassroots change in Queensland.

CRU's members include people with disabilities, families, workers from the disability field and community members.

CRU has statewide responsibilities, and works with a national and international network.

Management of CRU

The direction and management of Community Resource Unit is vested in the Committee of Management which is elected annually. Implementation of the programs is the responsibility of the CEO and the staff team.

Purpose

CRU exists to support the development of leadership and authentic change which enhance the possibilities for people with disabilities *to belong to and participate in community life*.

It aims to:

- Challenge ideas and practices which limit the lives of people with disabilities, and
- Inspire and encourage individuals and organisations to pursue better lives for people with disabilities.
