### **History and Governance:**

CRU was established in 1988 to support grass roots change in Queensland by a group of families, professionals and people with disabilities.

CRU was incorporated as an association in 1988 and transitioned to become a company limited by guarantee in March 2017.

The Governance of CRU is vested in the Board of Directors who are elected annually.

The implementation of CRU programs is the responsibility of the CEO and the staff.

CRU currently receives some funding from the State government.

CRU's work is also funded through project grants, workshops and fee for service consultancy work.

# **Notes regarding Membership**

- Payment covers members for the year or part thereof depending on when the application is submitted. Membership fees are due annually on OCTOBER 1st.
- 2. Only current financial members have voting rights.
- Application Forms must be signed by the applicant, a Proposer and Seconder (both of which must be members of CRU) and membership is subject to Board of Directors Approval. Applicants will be notified in writing and a Tax Invoice issued on acceptance of new membership by the Board of Directors.
- CRU is covered by public liability insurance.
