



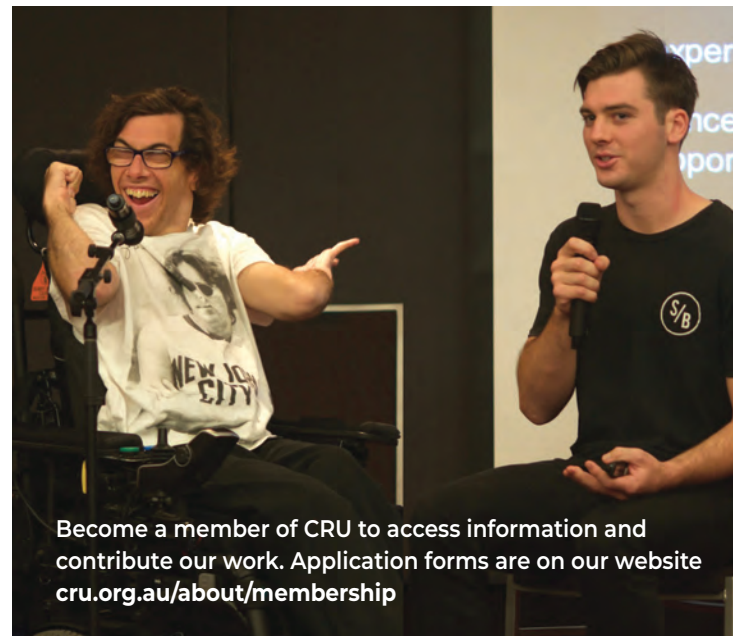
## About CRU
